## **INSPECTION NOTES**

This school has had complaints from staff of diesel odors within the building and some reports of symptoms such as irritated eyes and headaches. The employer initiated an indoor air quality investigation and has implemented a number of corrective actions. The following outlines actions taken:

- the employer requested that all vehicles parked on the West side of the school not idle
- the employer created sandwich boards to place on the West side of the school advising no idling allowed
- air intakes are located on the West side of the school, the HVAC system has been programmed to close the intakes between 7:30-9 AM and 1-3 PM
- indoor air quality monitoring of different rooms in the school has been conducted
- a carbon monoxide detector and particulate monitor were installed in the library and continue to operate
- an investigation report has been written for the actions taken
- the employer is awaiting carbon filters for the air intakes to be installed once they arrive

Indoor air quality monitoring results of three locations monitored for carbon dioxide, carbon monoxide, temperature and relative humidity were provided by the employer. A review of the results indicates that the levels measured were generally acceptable in accordance with indoor air quality guidelines. Transient levels of Carbon Monoxide did reach up to 0.9 ppm in the music room for short durations but returned to negligible levels. This is an indication that some exhaust was likely getting into the school HVAC system.

Since the controls have been implemented there have been a few additional reports of odors and symptoms in some rooms during the morning. Workers have been asked to log such events for further follow up.

If such events continue to be reported once the carbon filters are installed, then further action must be taken such as nitrogen dioxide air monitoring and/or moving the bus pick up drop/off location.
